**ORDINANCE NO. 13-03**

**AN ORDINANCE AMENDING TITLE 7, TRAFFIC REGULATIONS, CHAPTER 6, STOPPING, STANDING, PARKING, SECTION 7-6-1, PARKING PROHIBITED, OF THE MUNICIPAL CODE FOR THE VILLAGE OF MANTENO.**

BE IT ORDAINED by the President and Board of Trustees of the Village of Manteno, as follows:

**Section 1**

That Title 7, Traffic Regulations, Chapter 6, Stopping, Standing, Parking, be amended by changing Section 7-6-1, Parking Prohibited, to provide as follows:

"7-6-1:       **PARKING PROHIBITED:** It shall be unlawful for the operator of any vehicle to stop, stand or park such vehicle in any of the following places except when necessary to avoid conflict with other traffic or in compliance with directions of a police officer or official sign or signal:

...

(L)    Specific Streets:

Birch Street on the easterly or westerly side between Fourth Street on the north and Third Street on the south between the hours of one o'clock (1:00) A.M. and six o'clock (6:00) A.M.

Cook Street on the south side from Main Street to Walnut Street.

West Cook Street on the southerly side from its intersection with Poplar Street to its intersection with South Creek Drive.

Division Street on the northerly or southerly sides from the intersection of Cypress Street to its intersection with Walnut Street.

**Section 2**

Unless otherwise provided, the penalty clause for this ordinance shall be Section 1-4-1 of the Manteno Municipal Code.

**Section 3**

If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this ordinance.

**Section 4**

All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed insofar as they conflict herewith.

**Section 5**


This ordinance shall be immediately in full force and effect after passage, approval and publication. This ordinance is authorized to be published in pamphlet form.
