ORDINANCE NO. 14-08

AN ORDINANCE ANNEXING THE NYMEYER PROPERTY, CONSISTING OF APPROXIMATELY 45 ACRES OF LAND LOCATED SOUTHEAST OF 7000N ROAD AND 1000E ROAD TO THE VILLAGE OF MANTENO, KANKAKEE COUNTY, ILLINOIS

WHEREAS, a written petition signed by Gregory Nymeyer, Lisa Renee Adams, Kelly Ann Nymeyer, Hugh Nymeyer and Anna Mae Nymeyer, as Trustee of the Anna Mae Nymeyer Trust dated August 6, 2002, sole legal owners of record of all land within the territory hereinafter described, has been filed with the Village Clerk of the Village of Manteno, Kankakee County, Illinois, requesting that said territory be annexed to the Village of Manteno, Kankakee County, Illinois; and

WHEREAS, no electors reside within the territory hereinafter described;

WHEREAS, the said territory is not within the corporate limits of any municipality but is contiguous to the Village of Manteno;

WHEREAS, the legal owners of record of said territory and the Village of Manteno have entered into a valid and binding annexation agreement relating to such territory;

WHEREAS, all petitions, documents, and other necessary legal requirements are in full compliance with the terms of the annexation agreement and with the statutes of the State of Illinois, specifically Section 7-1-8 of the Illinois Municipal Code; and

WHEREAS, it is in the best interests of the Village of Manteno that the territory be annexed.

NOW, THEREFORE, BE IT ORDAINED by the Village President and Board of Trustees of the Village of Manteno, as follows:

Section 1

That the territory known as the Nymeyer Property, consisting of approximately 45 acres of land located southeast of of 7000N Road and 1000E Road, and legally described as follows:

The north half of the north half of the Northwest Quarter of Section 33 and that part of the north half of the north half of the Northeast Quarter of Section 33, which lies west of the Illinois Central Gulf Railroad right of way, all in Township 32 North, Range 12 East of the Third Principal Meridian in Kankakee County, Illinois;

being indicated on the plat of annexation attached hereto, is hereby annexed to the Village of Manteno, Kankakee County, Illinois.

Section 2

That the Village Clerk is hereby directed to record and to file with the County Clerk a certified copy of this ordinance.

Section 3

This ordinance shall be in full force and effect after passage and approval as provided for by law.

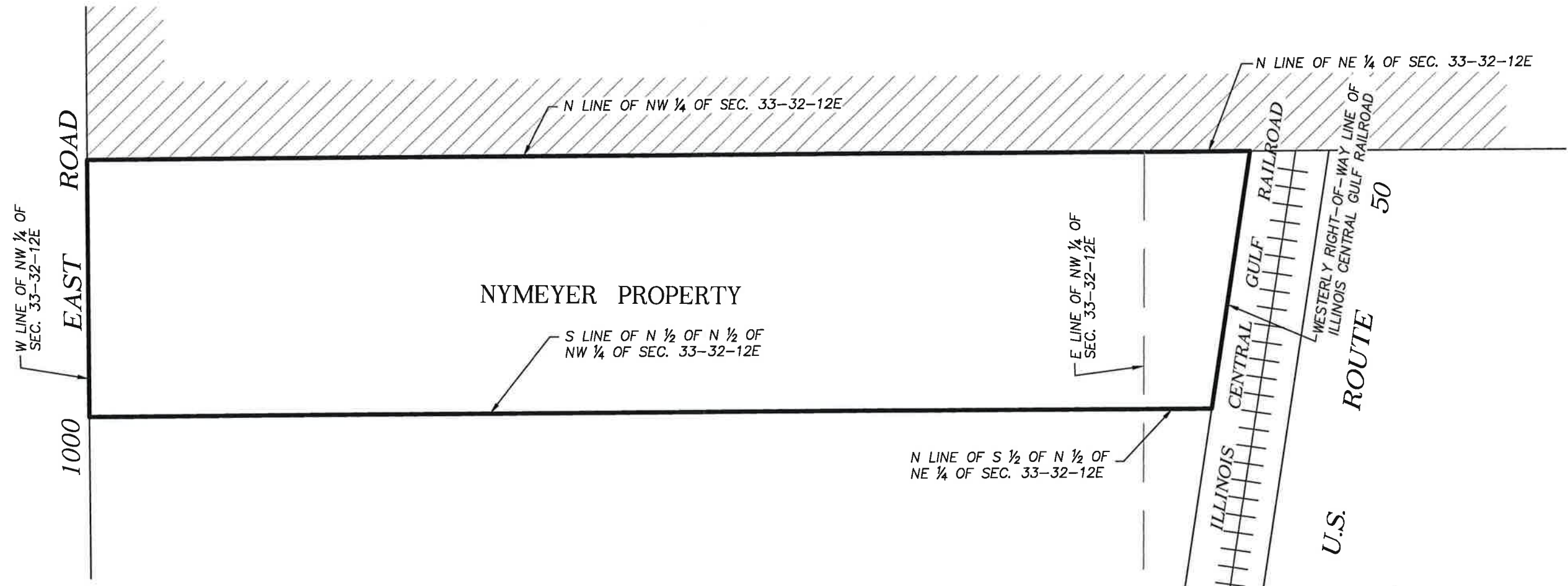
