

ORDINANCE NO. 14-25

AN ORDINANCE AMENDING TITLE 1, ADMINISTRATIVE , CHAPTER 1, BOARD OF TRUSTEES, BY CHANGING SECTION 1-6-6, COMPENSATION, OF THE MUNICIPAL CODE FOR THE VILLAGE OF MANTENO

BE IT ORDAINED by the Village President and Board of Trustees of the Village of Manteno, Kankakee County, Illinois, as follows:

Section 1

That Title 1, Administrative, Chapter 1, Board of Trustees, be amended by changing Section 1-6-6, Compensation, to read as follows:

1-6-6: COMPENSATION:

Each member of the board of trustees shall receive compensation as determined from time to time by the president and board of trustees, for each meeting of the board actually attended to include regularly scheduled board meetings, and special board meetings. Effective May 1, 2015, this rate will be one-hundred dollars (\$100.00) per meeting.

Board of trustees members serving on standing committees appointed by the president shall receive the same rate of compensation for meetings attended up to a maximum of three (3) committee meetings per month per trustee. Documentation of attendance must be reported by the committee chairman to the village clerk. These standing committees are listed in section 1-6-5, rule 9, of this chapter.

Section 2

If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this ordinance.

Section 3

All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed insofar as they conflict herewith.

Section 4

This ordinance shall be immediately in full force and effect after the passage, approval, and publication. This ordinance is authorized to be published in pamphlet form.
