

ORDINANCE NO. 15-15

**AN ORDINANCE AMENDING THE OFFICIAL COMPREHENSIVE
PLAN AND MAP FOR THE VILLAGE OF MANTENO**

WHEREAS, on July 13, 2015, the Plan Commission for the Village of Manteno (“Plan Commission”) did review and recommend to the Corporate Authorities of the Village of Manteno that an amendment to the comprehensive plan and map for the present and future development of land in and around the Village of Manteno be adopted;

WHEREAS, on July 20, 2015, pursuant to published notice, the Corporate Authorities of the Village of Manteno did hold a public hearing on the adoption of the amendment to the comprehensive plan and map for the Village of Manteno, whereat they did consider the testimony and/or submittals of all persons in favor or against said recommended amendment; and,

WHEREAS, the Corporate Authorities of the Village of Manteno deem it necessary and desirable to adopt an amendment to the comprehensive plan and map for the Village of Manteno to reflect changes in present and future land use and development in and around the Village of Manteno.

NOW, THEREFORE, BE IT ORDAINED by the Village President and Board of Trustees of the Village of Manteno, as follows:

Section 1

That the comprehensive map, as amended, attached hereto as Exhibit “A,” is hereby approved and adopted.

Section 2

That the comprehensive map, as amended, shall replace and supersede all prior versions, and shall be inserted and incorporated into the official comprehensive plan for the Village of Manteno.

Section 3

All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed insofar as they conflict herewith.

Section 4

This ordinance shall be in full force and effect after passage, approval as provided for by law.

Section 5

The amendment to the comprehensive plan and map shall become effective upon the expiration of 10 days following the date of filing of a notice of the adoption this ordinance with the Kankakee County Recorder.

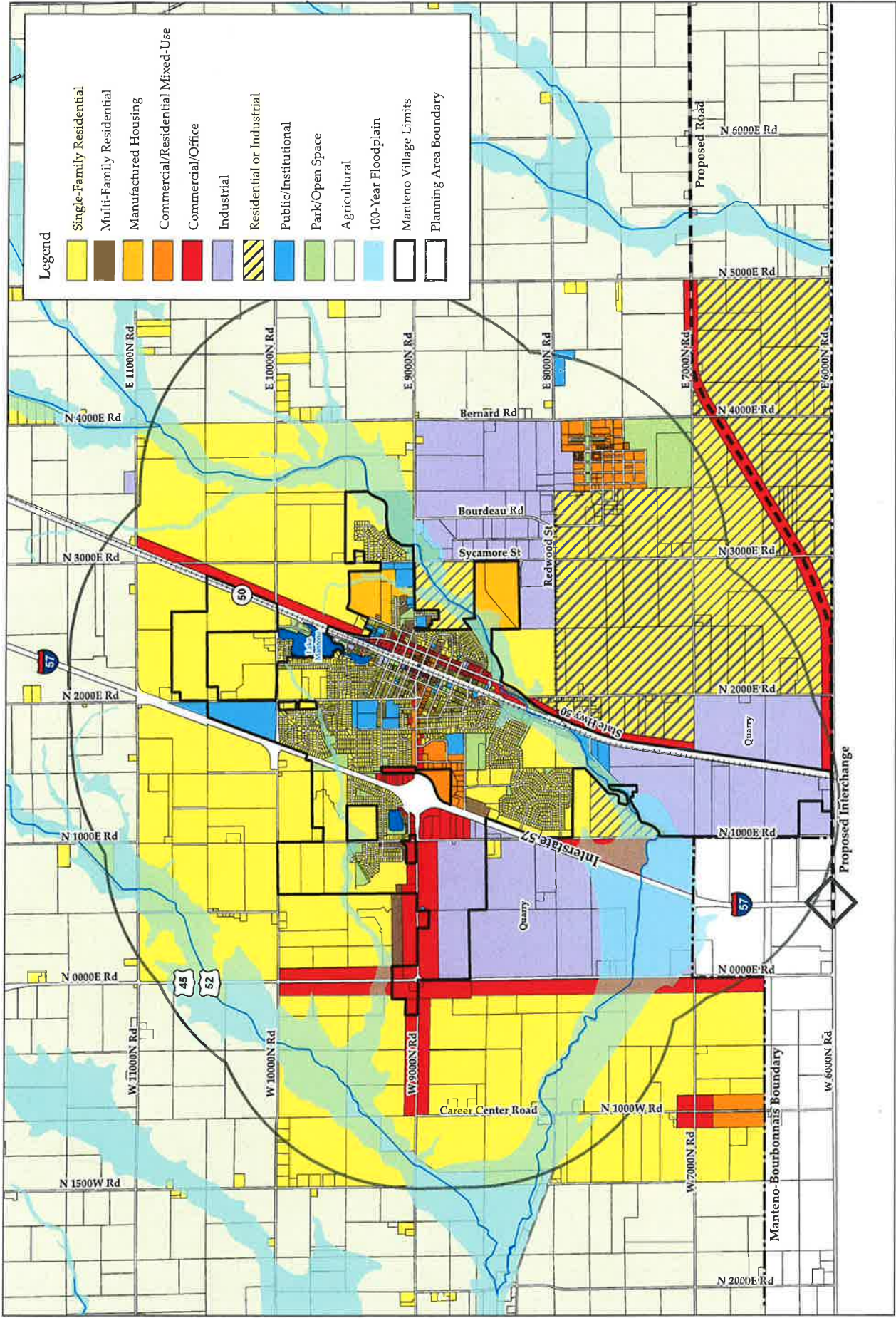


Figure 4.1: Future Land Use Plan
