## ORDINANCE NO. 15-38

### AN ORDINANCE AMENDING TITLE 10, SUBDIVISIONS, BY CHANGING CHAPTER 8, REQUIRED IMPROVEMENTS, DESIGN AND TECHNICAL STANDARDS, SECTION 10-8-9(B)9, ENTRANCES, OF THE MUNICIPAL CODE FOR THE VILLAGE OF MANTENO.

#### Section 1

That Title 10, Subdivisions, Chapter 8, Required Improvements, Design and Technical Standards, be changed by amending Section 10-8-9(B)9, to read as follows:

*"9. Entrances:*

- (a) Entrances on primary roads are to be a minimum of one hundred forty feet (140') from an intersection or another entrance.*
- (b) Entrances on secondary roads are to be a minimum of one hundred forty feet (140') from an intersection or another entrance.*
- (c) Residential driveways shall not be allowed direct access to primary or secondary roads.*
- (d) Entrance restrictions apply as described, unless otherwise approved by the Village Chief of Police and the Village Engineer. Any entrance/exit access that does not meet the distance requirement may be evaluated by the Village Chief of Police for traffic and safety concerns, and by the Village Engineer to determine if a shorter distance would be acceptable based on the particulars of the location. "*

#### Section 2

If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this ordinance.

#### Section 3

All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed insofar as they conflict herewith.

#### Section 4

This ordinance shall be immediately in full force and effect after passage, approval and publication. This ordinance is authorized to be published in pamphlet form.
