ORDINANCE ABATING THE TAX HERETO LEVIED
FOR THE YEAR **2016 AND ALL FUTURE YEARS** TO PAY
THE PRINCIPAL OF AND INTEREST ON \$1,455,000
GENERAL OBLIGATION BONDS

(Waterworks and Sewerage Alternate Revenue Source),

SERIES 2012, OF
THE VILLAGE OF MANTENO,
KANKAKEE COUNTY ILLINOIS

WHEREAS the President and Board of Trustees (the "Corporate Authorities") of the Village of Manteno, Kankakee County, Illinois (the "Village"), by Ordinance Number 12-05, adopted on the 21st day of May, 2012 (the "Ordinance"), did provide for the issue of not to exceed \$2,100,000 General Obligation Waterworks and Sewerage Refunding Bonds (Alternate Revenue Source), Series 2012 (the "Bonds"), and the levy of a direct annual tax sufficient to pay the principal of and interest on the Bonds; and

WHEREAS **the Village has sufficient funds to retire the debt in its entirety effective February 1, 2017**; and

WHEREAS the Village has the Pledged Revenues (as defined in the Ordinance) in the appropriate account or fund pursuant to the Ordinance for the purpose of paying the principal of and interest on the Bonds up to and including February 1, 2017; and

WHEREAS it is necessary and in the best interests of the Village that the tax heretofore levied for the year 2016 **and all future years** to pay the principal of and interest on the Bonds be abated;

NOW THEREFORE Be It Ordained by the President and Board of Trustees of the Village of Manteno, Kankakee County, Illinois, as follows:

Section 1. Abatement of Tax. The tax heretofore levied for the year 2016 **and all future years** in the Ordinance is hereby abated in its entirety.

Section 2. Filing of Ordinance. Forthwith upon the adoption of this ordinance, the Village Clerk shall file a certified copy hereof with the County Clerk of The County of Kankakee, Illinois, and it shall be the duty of said County Clerk to abate said tax levied for the year 2016 and all future years in accordance with the provisions hereof.


Section 3. Effective Date. This ordinance shall be immediately in full force and effect after passage and approval.
