ORDINANCE NO. 17-13

AN ORDINANCE AMENDING TITLE 7, TRAFFIC REGULATIONS, CHAPTER 4, THROUGH, ONE-WAY AND STOP STREETS, SECTION 7-4-7, STOP SIGNS AND THROUGH STREETS, OF THE MUNICIPAL CODE FOR THE VILLAGE OF MANTENO

BE IT ORDAINED by the President and Board of Trustees of the Village of Manteno, as follows:

Section 1

That Title 7, Traffic Regulations, Chapter 4, Through, One-Way and Stop Streets, be amended by changing Section 7-4-7, Stop Signs and Through Streets, to provide as follows:

“7-4-7: **STOP SIGNS AND THROUGH STREETS:**

...

(B) One-Way Stops: A one-way stop is hereby established for:

Clover Lane at its intersection with Spring Street.

Halfway Road at its intersection with Somerset Drive.

Northbound traffic on Marquette Place at its intersection with Division Street.

Northbound traffic on Rockne Drive at its intersection with Park Street.

Northbound traffic on South Creek at its intersection with Cook Street.

Southbound Traffic on Beauchamp Avenue at its intersection with Hesburgh Drive.

Spring Street at its intersection with Somerset Drive.

Spring Street at its intersection with Windfield Drive.

Tallgrass Lane at its intersection with Spring Street.

Westbound traffic on Brian Drive at its intersection with South Cypress Street.

Westbound traffic on Cook Street at its intersection with South Cypress Street.

...

(D) Three-Way Stops: A three-way stop is hereby established at:

Baker Street at its intersection with McGuire Drive.

Brian Drive with the eastern intersection with White Tail Bend.

Dolly Drive with its intersection with South Poplar Street.

Jeffrey Street at its intersection with South Walnut.

Longfellow Drive at its intersection with Jefferson Street.

Maple Lane at its intersection with Birch Street.

South Creek Drive at its intersection with West Cook Street.

Willow Street at its intersection with Hesburgh Street.

Fifth and Main Street.

Eighth Street at its intersection with North Walnut Street.

(E) Four-Way Stops: A four-way stop is hereby established at:

Brian Drive at its intersection with South Creek Drive.

Brian Drive with the western intersection with White Tail Bend.

Hesburgh Street at its intersection with North Water Tower Street and South Water Tower Street.

Jeffrey Street at its intersection with South Poplar.

North Maple Street at its intersection with West Seventh Street.

North Walnut Street at its intersection with West Third Street.

Park and Poplar Streets.

Poplar Street at its intersection with Cook Street.

The intersection of Cook Street and Walnut Street.

The intersection of Maple and Lake Manteno Road (10000 N. Road).

West Adams Street and South Poplar Street.

West Adams Street and South Elm Street

West Cook Street at its intersection with South Elm Street.

Willow Road at its intersection with Park Street.

...”

Section 2

If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this ordinance.

Section 3

All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed insofar as they conflict herewith.

Section 4


This ordinance shall be immediately in full force and effect after passage, approval and publication. This ordinance is authorized to be published in pamphlet form.
