

**ORDINANCE 17-22**

**AN ORDINANCE OF THE VILLAGE OF MANTENO, KANKAKEE COUNTY, ILLINOIS, PROVIDING FOR THE SALE OF SURPLUS PERSONAL PROPERTY**

BE IT ORDAINED by the President and the Board of Trustees of the Village of Manteno, Kankakee County, Illinois, as follows:

**Section 1**

The following personal property is hereby declared to be surplus property, which is no longer necessary or useful to, or for the best interests of the Village of Manteno: Vac-Con Truck 2005; V.I.N.: 2FZAATDC14AN11446.

**Section 2**

That Christopher LaRocque, Administrator, be hereby authorized and directed to sell the Vac-Con Truck 2005; V.I.N.: 2FZAATDC14AN11446; to Aqua Illinois, Inc. for the price of ONE HUNDRED THOUSAND AND 00/100 DOLLARS (\$100,000.00). The property shall be sold "as is" with no express or implied warranties.

**Section 3**

That Timothy O. Nugent, President, be authorized and directed to execute such documents and instruments as may be necessary to effectuate the sale and transfer of title of the surplus property referenced in this ordinance to the purchaser including, but not limited to, a bill of sale.

**Section 4**

If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this ordinance.

**Section 5**

All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed insofar as they conflict herewith.

**Section 6**

This ordinance shall be immediately in full force and effect after passage and approval as provided by law.
