AN ORDINANCE AMENDING TITLE 3, BUSINESS REGULATIONS, CHAPTER 12, PEDDLERS, SOLICITORS AND CANVASSERS, BY AMENDING SECTION 4, PERMIT AND BADGE FEES, OF THE MUNICIPAL CODE FOR THE VILLAGE OF MANTENO

WHEREAS, the Village of Manteno is a non-home rule municipality duly existing and subject to the laws of the State of Illinois; and

WHEREAS, Title 3, Chapter 12, Section 4, of the Manteno Municipal Code sets forth the requirements for Permit and Badge Fees; and

WHEREAS, the Village of Manteno believes such Section 3-12-4, Permit and Badge Fees, should be amended, and therefore is desirous of amending Section 3-12-4 to increase the required fees; and

NOW THEREFORE, BE IT ORDAINED by the Village President and Board of Trustees of the Village of Manteno, Kankakee County, Illinois, as follows:

Section 1

The recitals set forth in the above prefatory clauses are hereby adopted as the findings of Village of Manteno and are expressly incorporated herein as a part of this ordinance.

Section 2

That Title 3, Business Regulations, Chapter 12, Peddlers, Solicitors and Canvassers, be changed by amending Section 3-12-4, Permit and Badge Fees, to read as follows:

3-12-4: PERMIT AND BADGE FEES:

At the time the application is filed with the village clerk, the applicant shall pay a fee to cover the cost of processing the application and investigating the facts stated therein. The permit fee shall be twenty-five dollars (\$25.00) for each solicitor and peddler. In addition to the permit fees, each solicitor and peddler shall be responsible for the cost to produce his/her badge. Each badge shall cost one dollar (\$1.00) and shall only be valid for one day.

Section 3

If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this ordinance.

Section 4

All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed insofar as they conflict herewith.

Section 5

This ordinance shall be immediately in full force and effect after passage, approval and publication. This ordinance is authorized to be published in pamphlet form.
