ORDINANCE NO. 18-02

AN ORDINANCE AMENDING TITLE 7, TRAFFIC REGULATIONS, CHAPTER 6, STOPPING, STANDING, PARKING, SECTION 7-6-1, PARKING PROHIBITED, OF THE MUNICIPAL CODE FOR THE VILLAGE OF MANTENO.

BE IT ORDAINED by the President and Board of Trustees of the Village of Manteno, as follows:

Section 1

That Title 7, Traffic Regulations, Chapter 6, Stopping, Standing, Parking, be amended by changing Section 7-6-1, Parking Prohibited, to provide as follows:

"7-6-1 **PARKING PROHIBITED:**

It shall be unlawful for the operator of any vehicle to stop, stand or park such vehicle in any of the following places except when necessary to avoid conflict with other traffic or in compliance with directions of a police officer or official sign or signal.

(L) **Specific Streets:**

" . . .

Main Street on the westerly side within twenty-five feet (25') of the intersection of said Main Street with any of the following streets: Fourth Street, Third Street, Second Street, First Street, Division Street, Adams Street or Baker Street.

Main Street on the easterly side between Cook Street and the south entrance of the public parking lot.

Maple Street on the westerly side from Park Street to a point one hundred fifty feet (150') north of said intersection.

Section 2

If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this ordinance.

Section 3

All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed insofar as they conflict herewith.

Section 4

This ordinance shall be immediately in full force and effect after passage, approval and publication. This ordinance is authorized to be published in pamphlet form.
