ORDINANCE NO. 18 - 16

ORDINANCE ABATING THE TAX HERETO LEVIED
FOR THE YEAR **2018** TO PAY
THE PRINCIPAL OF AND INTEREST ON \$2,050,000
GENERAL OBLIGATION BONDS
(Alternate Revenue Source),
SERIES 2013, OF
THE VILLAGE OF MANTENO,
KANKAKEE COUNTY ILLINOIS

WHEREAS the President and Board of Trustees (the "Corporate Authorities") of the Village of Manteno, Kankakee County, Illinois (the "Village"), by Ordinance Number 13-12, adopted on the 5th day of August, 2013 (the "Ordinance"), did provide for the issue of not to exceed \$2,050,000 General Obligation Bonds (Alternate Revenue Source), Series 2013 (the "Bonds"), and the levy of a direct annual tax sufficient to pay the principal of and interest on the Bonds; and

WHEREAS the Village has the Pledged Revenues (as defined in the Ordinance) in the appropriate account or fund pursuant to the Ordinance for the purpose of paying the principal of and interest on the Bonds up to and including February 1, 2020; and

WHEREAS it is necessary and in the best interests of the Village that the tax heretofore levied for the year 2018 to pay the principal of and interest on the Bonds be abated;

NOW THEREFORE Be It Ordained by the President and Board of Trustees of the Village of Manteno, Kankakee County, Illinois, as follows:

Section 1. Abatement of Tax. The tax heretofore levied for the year 2018 in the Ordinance is hereby abated in its entirety.

Section 2. Filing of Ordinance. Forthwith upon the adoption of this ordinance, the Village Clerk shall file a certified copy hereof with the County Clerk of The County of Kankakee, Illinois, and it shall be the duty of said County Clerk to abate said tax levied for the year 2018 in accordance with the provisions hereof.

Section 3. *Effective Date.* This ordinance shall be immediately in full force and effect after passage and approval.

THIS ORDINANCE was passed by the Village President and Board of Trustees and deposited in the office of the Village Clerk this 3rd day of December, 2018.
