**A RESOLUTION OF THE VILLAGE OF MANTENO FOR THE PRELIMINARY DETERMINATION OF RATE FOR THE 2018 TAX LEVY**

BE IT RESOLVED by the Village President and Board of Trustees of the Village of Manteno, Kankakee County, Illinois, as follows:

**Section 1**

That the Preliminary Determination of Rate for the 2018 Village of Manteno Tax Levy is established at one million, seven hundred thirty thousand dollars (\$1,730,000.00), an increase of 1.57% over the 2017 total property tax extension, and is hereby presented and placed on file.

**Section 2**

This resolution shall be in full force and effect from and after its adoption and approval as provided by law.

Adopting the Tax Levy Ordinance

TRUTH IN TAXATION ACT

Municipalities With Territory Located in All Other Counties

NOT LESS THAN 20 DAYS PRIOR to adoption of Levy Ordinance::

1. Determine the amount of money estimated to be necessary to be raised by taxation
2. Compare the estimate for the current year with the final aggregate levy EXTENDED for the preceding year
3. Is current year levy MORE THAN 105% of preceding Year?

YES

Schedule public hearing for adoption of Tax Levy Ordinance Dec 3, 2018

In Cook County, MUST be held ONLY on the FIRST Monday in December

Provide Notice of the municipality's intent to adopt Ordinance NOT LESS than 7 days and NOT MORE than 14 days prior to hearing

Publish PH notice Nov 20, 2018

Form of Notice MUST comply with statute

Conduct hearing Explain reasons for proposed increase Permit residents an opportunity to be heard

Dec 3, 2018

NO

Pass Ordinance and file with County Clerk NO LATER THAN last Tuesday in December

Dec 3, 2018

or Dec 17, 2018 if necessary.
